*If you want to arrange a direct cremation, you can use an alternative container.*

*Alternative containers encase the body and can be made of material like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard or plywood bottom with a cardboard top.*

- Climate-controlled holding (refrigeration) up to 10 days

- Cremation *(additional charge for persons over 300 lbs.)*
- Cardboard cremation container *(required by CA state law)*
- Temporary plastic urn
- Storage of cremated remains up to 30 days

The charge for our basic services and overhead will be added to the total cost of arrangements you select. **(Note: These services are included in our direct cremations and direct burials).** This charge includes, but is not limited to availability of staff 24 hours per day, staff and facilities to respond to initial requests for services, consultation with the responsible party to determine the services desired, coordinating service plans with other parties involved in the final disposition of the deceased, filing of local death certificate and obtaining local permits with the appropriate department (there may be an additional fee charged by the local jurisdiction).
  - Transportation within the Service Area (Humboldt County) \$200
  - Transportation outside the Service Area (per mile, one way) \$3
  - Use of Climate Controlled Holding Facility \$150
  - Use of Climate Controlled Holding Facilities after 10 days (per day) \$50
  - Crematory Fee \$300
  - Additional Crematory Fee for persons over 300lbs \$300
  - Use of facilities and staff for brief private viewing (10 persons max.) \$175
  - Use of facilities for witnessing cremation \$175
  - Common scattering of cremated remains at sea \$125
